

# Cookies Policy

This Cookies Policy explains how China Unicom (Singapore) Pte. Ltd. (CUSG) and its affiliates (collectively "CUSG", "we", "us", and "ours") use cookies and similar technologies to recognise you when you visit our websites at [www.chinaunicomglobal.com/sg](http://www.chinaunicomglobal.com/sg) ("**Websites**"). It explains what these technologies are and why we use them, as well as your rights to control our use of them. By using the Websites, you are accepting and consenting to the practices described in this Cookies Policy.

## What are cookies?

Cookies are small data files that are placed on your computer or mobile device when you visit a website. Cookies are widely used by website owners in order to make their websites work, or to work more efficiently, as well as to provide reporting information. Cookies set by the website owner (in this case, CUSG) are called "first party cookies".

## Why do we use cookies?

We use first party cookies for several reasons. Some cookies are required for technical reasons in order for our Websites to operate, and we refer to these as "essential" or "strictly necessary" cookies. Other cookies also enable us to track and target the interests of our users to enhance the experience on our Websites. This is described in more detail below.

The specific types of first party cookies served through our Websites and the purposes they perform are described in the table below:
